BSS EXAMINER NEWS

Dear Examiner,

This edition of BSS Examiner News provides an update on the examiner web improvements, invites you to apply for your place on the examiner electrical training and assessment course and asks you to contribute to an important safety survey about the effectiveness of older portable fire extinguishers.

1. Examiner website update

In this newsletter, you will learn that the examiner website can now be used to book your place on examiner training courses and the way to participate in important safety surveys with examiners.

The BSS Examiner material ordering facility went live on 7 May and things seem to be going well with report pads and certificates generally arriving with examiners on time, although we cannot stress too much the importance of predicting ahead and ordering in good time (see item 6). Please follow the 'How to Guide' closely if difficulties and stress are to be avoided when attempting to order materials.

The next facility to be launched will be online examination recording planned for a staged release very soon. We are currently working with an examiner test group to help refine the process and as soon as it is running smoothly, it will be released to further batches of examiners.

The next website item to arrive will be another 'How to Guide'. It will take you through amending your own personal details or county listings etc and will offer you the choice to add the initials of your professional organisation, e.g. MABSE or IMarEST, to your details. This additional feature will be part of a new look 'search for an examiner' results page coming soon to the public website.

Other eagerly awaited website features such as technical and policy guidance supporting the examiner role will be rolled out on the examiner website throughout the second part of the year, beginning in August.

2. Bullseye fire hazard

Remember the article about the fire hazard presented by bullseye, domed glass or prismatic decklights in BSS Examiner News 06-010 and the FAQ in Technical Newsletter TN01/07?

Examiner lain Jones provided this excellent photo illustrating the potential for direct sunlight to be magnified causing any surrounding combustible materials to heat up and/or catch fire? I thought you would like to see the photo.

Remember that if you find scorching beneath a bullseye decklight, you must inform the owner of the obvious risk; record the fact that the owner has been informed and report the details to the BSS Office, by email, fax or phone.



3. Portable fire extinguisher (PFE) survey

At the BSS Technical Committee the question was raised about the level of assurance provided by older PFEs and any need for servicing or replacement.

At present, BSS examiners visually check compliant PFEs are in general good condition and only PFEs having passed the manufacturer's express 'expiry' or 'replace by' dates have to be supported by evidence of servicing in accordance with BS 5306 by a service technician.

Although the BSS database is a far from records are incomplete applies; the general impression from incident records collected by the BSS is that PFEs generally work and work effectively to help prevent small fires from escalating. We have no records of PFEs failing to operate when needed but we have seen anecdotal reports of a failure and partial discharges.

In order to help the BSS Technical Committee decide upon this question, a survey of examiners knowledge and experience of any PFE failures or partial failures to discharge is seen as a very important source of evidence.

It is very important for the quality of the research that you complete the survey, whether you know of any PFE failures or not.

4. BW re-organisation – impact of BSS Office staffing?

Some of you will have heard about British Waterways' (BW) internal restructure of its operations and, as the BSS is administered by BW, may be wondering how or if this affects BSS Office staff. The plans include the removal of a layer of BW management and, subject to consultation with staff and trade unions, approximately 100 redundancies from office staff.

The BSS is moving from within the BW Technical Directorate to the BW Operations Directorate but at present, there is no threat to the BSS staffing levels, which are reducing under a pre-existing business plan. For more information about BW's plans visit:
