Mandatory Pre-Examination Written Agreements Reminder

From April 2024, Examiners have been required by their **Conditions of Registration** (CoR) **clause 7.2** to have a written agreement in place with the boat owner or their representative before commencing a BSS Examination. Examiners must provide the BSS or its representative copies of these agreements on request.

The written agreement is mandated for the protection of BSS Examiners, so that the Scheme can quickly deal with any disputed claims by boat owners and operators.

The minimum information required in such a written agreement are set out in a useful guiding Appendix, see below.

CoR Appendix One specifies the following minimum content:

- a) BSS Examiner's trading name & contact details
- b) Boat name & navigation authority registration number, and other identifying information
- c) Owner's name or representative and contact details
- d) Date & time of agreed BSS Examination
- e) Type of BSS Examination requested private, non-private, hire
- f) Is the boat CE/UKCA marked
- g) Requirement that the owner must declare whether the boat is a private leisure or pleasure boat or workboat, or whether (for the purposes of the Gas Safety (Installation and Use) Regulations (GSIUR)) the boat is:
 - hired out in the course of a business;

- where persons are invited on board in the course of a business (e.g. café, shop or hotel boat); or,
- used primarily for domestic or residential purposes.
- What is the cost & what is included, BSS Examination, travel, re-Examination if required
- h) It must also include this statement: "This agreement only covers the BSS Examination(s) of [your customers] boat and where appropriate provision of BSS Certification and no other work".

Timescale for Reporting Non-Compliant results (aka 'No' result or failure Examinations)

The 2024 CoR also included a small adjustment to the timescale policy for recording Examinations. All BSS Examinations, whether the result is compliant or non-compliant, must be recorded within 48 hrs apart from an infrequent exception that can only be used by prior agreement with the owner. This exception must not be longer than 5 days. See more information on this policy here [LINK].

Boat Safety Scheme Governance Arrangements

Following the completion of a governance review of the Boat Safety Scheme and the incorporation of Boat Safety Scheme Limited, the governance documents and an explanatory note summarising the governance arrangements have been published on the BSS website [LINK].

It includes the Boat Safety Scheme Memorandum of Understanding between the Canal & River Trust, the Environment Agency, the Broads Authority, AINA and Boat Safety Scheme Limited, with the Terms of Reference for the new Navigation Authority Standards Setting Forum and the Boat Safety Scheme Advisory Forum (BSSAF) and Technical Forum (BSSTF).

Membership of the BSSAF and BSSTF will be mapped across from the old BSS committee membership and this will be reviewed in early 2025*.

The membership of the SSF will be representatives from the Broads Authority, Canal & River Trust and Environment Agency, known as the Nominating Bodies. The SSF Convener will issue a standing invitation to the following list **:

- AINA to nominate representative from time to time
- BSS Limited General Manager
- Convener of the BSS Advisory Forum
- Convener of the BSS Technical Forum
- User groups representative (nominated by BSS Advisory Forum membership bodies, with the representative chosen from nominees by the Convener for a 3-yr term).
- Marine trade representative (nominated by British Marine from time to time)
- BSS examiner representative (nominated by ballot of current BSS examiners for a 3-yr term)

This ballot of Examiners is being arranged by an independent third-party organisation and we will announce more details shortly, so please keep a watch out for more information about this initiative.
